Course participants can opt to either:

(i) follow the accredited pathway by subjecting themselves to the prescribed assessment, which would make them eligible to receive a certificate for every Study-Unit or to simply(ii) attend the Course, which would make them eligible to receive an attendance certificate upon successful completion.

Participants opting for the first pathway will be registered as University of Malta students.

The assessment participants can expect during the duration of the Training Course consists mainly of group work, mainly in the form of three (3) written group assignments and three (3) group presentations, although each participant will be assessed individually.
